

General Contest Terms & Conditions

1. All prizes must be picked up within 90 days of winning.
2. Coast will not notify the winners of time remaining – it is the sole responsibility of the winner to claim their prize. All unclaimed prizes will be forfeited.
3. In the event a winner chooses not to accept a prize, they forfeit any claims to the prize, which can then be awarded to a runner-up at the discretion of Hauraki
4. Coast is at liberty to dispose of an unclaimed prize at the end of 90 days.
5. If the specified prize is unavailable due to unforeseen circumstances Hauraki may substitute another prize of similar or equal value.
6. Coast is not responsible for defective prizes or misuse of a claimed prize.
7. The prizes are not redeemable for cash or transferable. Only the person who originally entered the promotion can be awarded the prize. No other family members, friends, office associates or any other person will be able to participate on another person's behalf.
8. Prizes valued under \$50.00 may be mailed at the option of Coast; all other prizes must be claimed in person, unless otherwise specified. ID which includes a photo will be required (Examples are drivers license / passport / student card with photo).
9. If in the course of the contest, prior to confirming the winner's identification and address, the phone line drops out or becomes disconnected for any reason, Coast is not responsible for awarding such prize to that caller and will go on to the next available caller.
10. INELIGIBILITY: A person is ineligible to enter and / or win a competition if:
11. They are an employee or a member of a family of an employee of Coast, its Advertising Agency / Radio Network / Sponsors and affiliates;
12. They have won a prize in a Coast competition valued at more than \$50.00 in the 60 days prior to the day they enter the competition.

19. All contest entries become the property of Coast. All personal details provided to participate in these promotions will be held by TRN for the purpose of this promotion and entries may be used by the TRN for future promotional and marketing purposes, unless otherwise advised by entrants.
20. By participating, all winners grant TRN exclusive permission to use their names, characters, photographs, voices and likeness in connection with promotion of this and other contests and waive any claims to royalty, right or remuneration for such use.
