

## \$10,000 BIG SPENDER

### Specific Terms and Conditions

#### Description

Coast, which is brought to you by NZME Radio Limited (the “Promoter” or “Coast”), is presenting the **BIG SPENDER** (“Promotion”). To participate you must listen to Coast between 6:00am and 6:00pm for the cue to call. Caller **ten** (10) on 0800 004COAST (0800 004262) will be given the opportunity to select if the value of the named item is HIGHER or LOWER than the stated value. A correct answer is entry into the **BIG SPENDER** grand prize draw.

The **BIG SPENDER** grand prize draw will be made on a date yet to be confirmed during the Coast Feel Good Breakfast. One winner will be selected by random draw and then contacted on the phone number provided. The Big Spender must be available to shop on the nominated day.

To be confirmed as the **BIG SPENDER** winner you must:

- a) Answer your phone within 8 rings (as heard at the Coast studio) or prior to your answerphone message activating. Should this not happen additional names will be drawn, and calls made until an entrant successfully answers their phone within the stipulated number of rings.
- b) Be available on the nominated day between 8:00am and 5:00pm to complete the \$10,000 shopping spree.

Multiple entries of ONE (1) per person per day are permitted.

#### Promotional Period

The Promotion starts on 20<sup>th</sup> October 2021 and ends once we are able to confirm the nominated shopping day. The shopping spree will only be held when we are able to fully conform with all Government Covid-19 requirements. The competition runs on standard weekdays (Monday – Friday). Excluding weekends and public holidays (except for regional anniversary days).

#### How to Win

To be eligible to enter the Promotion, you must be:

- 1) 18 years of age or older
- 2) Heard the **BIG SPENDER** cue to call
- 3) Called Coast on 0800 004COAST (0800 004262)
- 4) Been selected as caller number **ten** (10)
- 5) Correctly identified the value of the named item
- 6) **Be selected as the grand prize winner**
- 7) Are available to complete the \$10,000 shopping spree on the nominated date between 7:00am and 7:00pm
- 8) Eligible under NZME’s Standard Promotion or Competition Rules below.

## Prize

**BIG SPENDER** prize:

- ONE (1) \$10,000 shopping spree

These additional conditions apply to the conduct of the \$10,000 shopping spree:

- a) The total \$10,000 amount must be spent between 9am and 12 noon on the nominated day.
- b) Any unspent amount will be forfeited.
- c) The winner will be accompanied Coast team members (and a vehicle will be on hand to collect shopping) and must conform with Government mandated requirements (vaccination certificate, wearing masks, observing person to person separation rules etc.).
- d) The winner will be required to participate in live crosses each hour throughout the day.
- e) The winner may donate part of the prize amount, up to a maximum of \$1,000 to one (1) charity.
- f) The winner may use up to a maximum of \$1,000 to make online purchases, these must be made on the nominated day.
- g) In-store shopping must be done within Auckland city area (refer to official Auckland City map for details of this area)
- h) The winner may use up to a maximum of \$1,000 to make gift card purchases.
- i) The winner may not use any of the prize money allowed to gamble or for any type of illegal activity.
- j) Coast will provide return airfares for the winner and a partner to Auckland for the nominated day to participate (if required).

## General

## STANDARD PROMOTION OR COMPETITION RULES

### Definitions

'NZME' means all companies in the NZME Group including but not limited to NZME Holdings Limited, NZME Publishing Limited, NZME Radio Limited, GrabOne Limited and all brands and operating companies controlled by or associated with those entities.

The '**Promoter**' is NZME.

'**Disqualified Participants**' are:

- (a) all NZME employees, all employees of participating sponsors or promoters and/or advertising agencies and their Immediate Families;
- (b) all people under the age of 18 years where the prize incorporates air travel or any other element which would be illegal to supply to a person under the age of 18 years;
- (c) all people who have won a prize from the channel/station running this promotion in the last 14 days. If the previously won prize was valued at over \$1,000 the winner must stand-down from entering for a period of 90 days.

'**Immediate Families**' include spouses, grandparents, parents, children, and grandchildren, whether by marriage, past marriages, remarriage, adoption, co-habitation or other family extension.

## Entry

1. These Promotion or Competition Rules ('the **Rules**') apply to all NZME Promotions or Competitions (collectively the '**Promotion**') conducted on or off air and by means of any medium – online, radio, print, or a connected device. The Rules may change from time to time.
2. If a particular Promotion has specific rules or terms ('the '**Specific Rules**') those Specific Rules will apply if there is any inconsistency with the Rules.
3. Unless otherwise stated in the Specific Rules registration, entry or vote is limited to 1 per person. Where multiple registrations, entries or votes are acceptable, each must be made separately.
4. Entry into the Promotion is deemed to be acceptance of the Rules and the Specific Rules and confirmation that the entrant has the necessary authority (for example from the bill payer or owner of a telephone) to enter the Promotion.
5. No purchase is necessary to win or participate in the Promotion, unless specified in the Specific Rules.
6. The Promotion is open to New Zealand Residents only. Disqualified Participants may not enter in the Promotion.
7. NZME reserves the right to exclude any person from participating in the Promotion on reasonable grounds.
8. NZME reserves the right to refuse to award any prize to an entrant who NZME decides (in its sole discretion) has violated the Rules (including the Specific Rules), gained unfair advantage in participating in the Promotion or won using fraudulent means.
9. By participating, entrants grant NZME exclusive permission to use their names, characters, photographs, videos, voices and likeness in connection with the Promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.
10. All entrant personal details must be valid and up to date and will be held by NZME and may be used for the purpose of the Promotion and for future promotion and marketing purposes in accordance with NZME Privacy Policy (see [www.NZME.co.nz](http://www.NZME.co.nz)) unless otherwise directed by contestants at the time of entry.
11. Personal information provided at the time of entry is presumed to be true and, in the case of text or email notification – active, through to and beyond the date of the Promotion's completion.

## Winning the Prize

12. Only the person who originally entered the Promotion can be awarded the prize (the '**Winner**').
13. The Winner will be determined in the manner set out in the Rules or the Specific Rules – if not specified then as determined by the Promoter who shall for this purpose be deemed the judge (the '**Judge**').
14. The Judge's determination of the Winner will be final and no correspondence will be entered into.
15. The Winner will be notified by email, phone (voice or text), mail or in person and must be available for the preparation of all publicity that may be required by NZME. Where attempts to contact the Winner fail (eg when the Winner cannot be contacted by phone after three attempts or mail sent is returned) the Judge will select another winner. If, after successful notification, the prize is not collected within two months of being announced it will be regarded as forfeit. (Note: 3 attempts to contact the Winner will include individual calls to any numbers provided at the time of entry. However, should the prize's total worth equal less than NZD\$250 and be a live-to-air draw, only one failed attempt at contact will be acceptable before the Judge selects another winner.)
16. The Prize is not transferable. No other family members, friends, office associates or any other person will be able to participate on the Winner's behalf. In the event that the Prize specified in the Competition becomes unavailable for any reason the Promoter may substitute a prize of like or equal value.
17. Where the Winner is required to claim the prize in person, they must provide proper identification (eg driver's licence, passport, birth certificate). If the Winner is under the age of 18 years their parent or legal guardian must accompany the Winner or give their prior written consent to the award of the Prize.
18. The Winner takes the Prize entirely at his/her own risk and indemnifies NZME in respect of any claim for any accident, injury, property damage or loss of life that may occur in connection with the prize. Where the Prize has associated terms and conditions the Winner accepts the Prize subject to those terms and conditions and restrictions.

## NZME Responsibility

19. NZME reserves the right to amend, vary, extend or discontinue a Promotion at any stage, for any reason.
